**Circular**

**Subject:- Appointment of Director of 07 National Institutes (Autonomous Bodies) under the administrative control of DEPwD.**

Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice & Empowerment, Government of India invited **online applications** for filing up the post of Director of 07 National Institutes (SVNIRTAR, Cuttack; NILD, Kolkata; PDUNIPPD, Delhi; NIEPVD, Dehradun; NIEPMD, Chennai; AYJNISHD, Mumbai and NIEPID, Secunderabad) under DEPwD. The last date for receiving of applications was 19<sup>th</sup> May 2023 (till 5 PM).

2. The Department has been in receipt of 364 applications from 262 applicants for various posts. All these applications were screened by 4 Screening Committees constituted by the Department. Minutes of the 4 screening committees were placed on the website of the Department on 12<sup>th</sup> June 2023 for a period of 7 days i.e. upto 19<sup>th</sup> June 2023 inviting representations.

3. The Department has been in receipt of 42 representations. The representations were again placed before aforementioned 4 screening committees. Minutes of the 4 screening committees, disposing-off all representations, is enclosed as Annexure 1. It is conveyed that no further representations will be entertained.

4. The list of 48 shortlisted candidates for the post of Director of aforementioned 07 National Institutes is placed at Annexure 2.

5. All the shortlisted candidates are conveyed that the interviews for the post of Director of aforementioned 07 National Institutes will be held at Conference Room, B-III Block, Department of Empowerment of Persons with Disabilities, 5<sup>th</sup> floor, Pandit Deendayal Antyodaya Bhawan, CGO Complex, New Delhi, as per the following schedule:


