The applications are inviting from eligible candidates for admission in **Diploma in Indian Sign Language Interpretation – DISLI course** for the academic year 2024-25 at NIMHR Sehore.

Syllabus

➤ Diploma in Indian Sign Language Interpretation (DISLI)

Objectives - 1) The main objective of the programme is to train Indian Sign Language interpreters to provide communication access to Deaf and Hard of Hearing people in various settings in real life.

2) Explore Deaf culture and society and study the structure and use of Indian Sign Language (ISL).

3) Increasing understanding of the principle, ethics relating to ISL interpretation in the field.

Duration of the Course: - 2 years

Eligibility for admission: - A Candidate should have:

- Senior Secondary (10+2) or equivalent with minimum 50% marks
- Functional hands
- Fluency in at least one language
- Hearing in the normal range

Admission Process: -

The direct admission process will be carried out as per the RCI standard rules and practices.

Application Fee: - Rs. 200/- (The candidate who have UDID card and 40% disability certificate and their parents will be exempted) will be paid by the candidate in the name of account no. NIMHR Sehore, Account no. 40714185629, IFSC code SBIN0000477. Applicants can also pay through QR code as given below.

- **All the students and their parents who get selected in the courses who are having disability certificate as well as valid UDID card or enrolled on UDID portal will be exempted from payment of tuition fee.**
- Hostel facility will be available tentatively and the charges will be extra as per the norms of NIMHR.
- Initially a stipend of Rs. 2000/- per month for each student will be provided for 10 months per year, for duration of 2 years.
- Parents of PwDs can also take the admission in the course, but they will not be entitled for stipend.
- At the time of admission, each shortlisted candidate must have mandatorily deposit tuition fee of minimum Rs. 5000.00 (Rupees Five Thousand Only). Failing to do so, his/ her candidature will be treated as cancelled. For details of fees structure, please refer the para “**Course Fee**” of respective course.
